Introduction

El Segundo Mine is located in McKinley County on both sides of New Mexico State Highway 509 approximately 35 miles North of Grants, NM. Mining activities will be conducted within 100 feet of the right of way, of Highway 509. The permit area consists of approximately 16,559.02 acres in Sections 19, 20, 21, 22, 25, 26, 27, 28, 29, 30, 34, 35 and 36 of T17N,R10W in Orphan Annie Rock and Laguna Castillo USGS Quad maps; Sections 31, 32, 33, 34 and 35 of T17,R9W in Orphan Annie Rock USGS Quad maps; Sections 1, 2, 3, 11, 12, 14, 23, 25 and 26 of T16N,R10W in Orphan Annie Rock, Laguna Castillo, and Mesa de los Toros USGS Quad Maps; Sections 3, 4, 5, 6, 7, 8, 18, 19, 28, 29, 30, 33, 34, 35 and 36 of T16N,R9W in Piedra de la Aguila, Mesa de los Toros and Orphan Annie Rock USGS Quad Maps; Sections 6, 7, 17, 18, 20, 28 and 29 of T15N,R8W in Piedra de la Aguila, USGS Quad Map; and Section 31 of T16N, R8W in Piedra de la Aguila USGS Quad Maps.

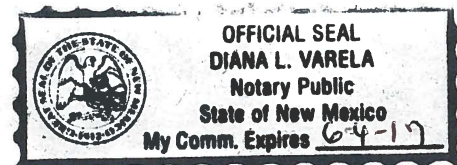

THE CONDITION OF THE ABOVE OBLIGATION is such, that:

Whereas, the Principal has submitted to MMD an application for surface coal mining and reclamation operations, MMD Permit No. 2015-01, including a mining and reclamation plan, to conduct and reclaim a surface coal mining operations, as defined in the New Mexico Surface Mining Act, Sections 69-25A-1 et seq. NMSA 1978, (New Mexico Act) and the regulations of New Mexico Coal Surface Mining Commission 19.8 NMAC.

Whereas, the Principal has chosen to provide this Surety Bond as a guarantee that the reclamation of the land disturbed during this surface mining operation at the Mine, McKinley County, State of New Mexico, will be performed and completed as required by the New Mexico Act and CSMC Rule 19.8 NMAC, and as specified or included by reference or adoption in the Permit as issued or modified;

Whereas, the Surety and their successors and assigns agree to guarantee the obligation

and to indemnify, defend, and hold harmless MMD from any and all losses and expenses which MMD may sustain as a result of the Principal's failure to comply with the condition of the obligation;

Whereas, obligations guaranteed by this Surety Bond shall be in effect for the following described lands approved as the permit areas or increments upon which initial of succeeding operations will be conducted:

If the Principal faithfully completes all reclamation and abatement requirements set forth in the , the New Mexico Act, CSMC Rule 19.8 NMAC and the Permit, including the mining and reclamation plan, and MMD has approved said completion, then this Surety Bond shall be void; otherwise, it shall remain in full force and effect:

- (a) beginning on the date of the approval and issuance of MMD Permit No. 2015-01 and extending until all reclamation, restoration, and abatement work pursuant to the New Mexico Act, CSMC Rule 19.8 NMAC and the Permit has been performed and completed to the satisfaction of MMD; and
- (b) continuing until the bond is released pursuant to 19.8.14.1412 NMAC, replaced in accordance with 19.8.14.1411 NMAC or until the Permit has been sold, reassigned or otherwise transferred in accordance with 19.8.13.1307 NMAC; and
- (c) for a minimum period of ten (10) years from completion of reclamation, notwithstanding the requirements of this paragraph and subparagraph (a) above, it being further understood that if the Principal performs any augmented seeding, fertilization or other supplemental reclamation work on the site prior to bond release, the period of liability under this Surety Bond shall begin again on the date such work is completed and, if required, approved by MMD, unless subject to the exception found in 19.8.20.2065.B NMAC.

The failure of the Principal to fulfill the obligations specified by the New Mexico Act, CSMC Rule 19.8 NMAC and the Permit, shall result in a forfeiture of this Surety Bond according to the procedure described in 19.8.14.1413 NMAC.

THE SURETY AGREES THIS BOND SHALL NOT BE CANCELED AT ANY TIME FOR ANY REASON, INCLUDING, BUT NOT LIMITED TO, NONPAYMENT OF THE

PREMIUM OR BANKRUPTCY OF THE PRINCIPAL DURING THE PERIOD OF LIABILITY.

The amount of the Surety's liability may be reduced by MMD pursuant to 19.8.14.1405 NMAC, for lands covered by this Surety Bond which have not been and will not be disturbed by the Principal, upon application by the Principal pursuant to 19.8.13.1301 NMAC, for revision of the Permit to delete such acreage as approved by MMD. This Surety Bond may also be reviewed by MMD annually, at permit mid-term or at other more frequent periods as deemed necessary, pursuant to 19.8.14.1405 NMAC. Pursuant to any such review, MMD may require an increase in this Surety Bond.

The Surety hereby agrees to give prompt notice to the Principal and to MMD of any notice received or action filed alleging the insolvency or bankruptcy of the Surety, or alleging any violations or regulatory requirements which would result in suspension or revocation of the Surety's license or powers to do business.

Upon the incapacity of the Surety by reason of bankruptcy, insolvency, or suspension or revocation of its license, the Principal shall be deemed without bond coverage in violation of 19.8.14.1401 NMAC, and subject to enforcement action described in 19.8.14.1406 NMAC.
