4. ***Case No. 15855: (Status Conference) (Continued from the April 23, 2020 Commission Hearing)***
Application of Delaware Energy, LLC to revoke the injection authority granted under SWD-1680 for the Alpha SWD No. 1 Well operated by Alpha SWD Operating, LLC, Eddy County New Mexico

5. ***Case No. 21233 (De Novo Case No. 20961): Application of Permian Oilfield Partners, LLC for approval of salt water disposal well in Eddy County, New Mexico.*** Applicant seeks an order approving disposal into the Devonian-Silurian formation through the **Ramrod Fee SWD #1** well at a surface location 323 feet from the South line and 2,227 feet from the East line of Section 17, Township 21 South, Range 28 East, NMPM, Eddy County, New Mexico for the purpose of operating a salt water disposal well. Applicant seeks authority to inject salt water into the Devonian-Silurian formation at a depth of 12,851' to 13,530'. Applicant further seeks approval of the use of 7 inch tubing inside the surface and intermediate casings and 5.5 inch tubing inside the liner and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day. Upon application of the New Mexico State Land Office, this case will be heard De Novo pursuant to the provisions of Division Rule 19.15.4.23 NMAC.
